A Celebration of Life Service for Stephen DeVaughn will be at 11:00 AM Friday, July 3, 2015 at Anderson-Burriss Funeral Home, with Mr. Brian Meyers officiating. Visitation with the family will begin at 10:00 AM until service time. Stephen was born December 25, 1948, to W.A. "Dell" and Berta Lee Stephens DeVaughn in Henryetta, Oklahoma, and passed away June 22, 2015, in Enid. Stephen graduated from Henryetta High School in 1967 where he played football. As an Eagle Scout, scouting was very important to him. Stephen graduated from Phillips University in 1972. After graduation, he went to work for the U.S. Treasury Department Customs Division as an Agent. Stephen served with the Secret Service on the Personnel Protection Service of President Gerald Ford. Later, he served as the Special Agent in Charge of the New Orleans Division, New York City and Criminal Divisions of Custom Enforcement. Upon retiring as Director of Criminal Investigation in Washington D.C. and traversing all over the world with International Law Enforcement, Stephen moved to Enid, Oklahoma in June 2000. In Enid, he continued his passion of serving by participating in the Meals on Wheels for twelve years, the Enid Police Commission serving as Chairman, and the Enid Fire Commission as Chairman. He thoroughly enjoyed his special friends of his morning and afternoon coffee groups. Stephen knew he was greatly loved by his family.
